In exercise of powers conferred by sub-section (1) of Section 13 C of the Representation of the People Act, 1950 (43 of 1950), the Election Commission of India hereby designates, all such officers who have been notified under Section 13 B and Section 13 C of the aforesaid Act, as Electoral Registration Officers and Assistant Electoral Registration Officers of all the assembly constituencies in the State of Karnataka, as Assistant Electoral Registration Officers of the respective Graduates' and Teachers' Constituencies in which the aforesaid assembly constituencies fall.
